

**BUCKEYE LOCAL BOARD OF EDUCATION MEETING  
SUMMARY**

The Buckeye Local Board of Education met in regular session on Monday, March 27, 2006, at 7:00 p.m. at Buckeye West Elementary, Adena. In attendance were Mr. DeLuca, Mrs. Kolkedy, Mr. Moore, Mr. Signorini. Mr. Moore presided over the meeting in the absence of President Zelek. Also present were Mr. Pielech, Ms. Prebeg, and Mr. Donahue. Minutes of previous meeting were approved as mailed. Treasurers report was approved as presented. Mr. Moore gave the invocation and led the Pledge of Allegiance. Mr. Moore welcomed all those in attendance.
